In the Community




Over the summer, my team and I hosted a very successful Participatory Budgeting process in Henry Farm. Residents came up with great ideas to improve the neighbourhood. The successful projects include lighting improvements in Havenbrook Park and resurfacing the Henry Farm Tennis Club courts. Thank you to the over 180 Henry Farmers who came to share their feedback on voting day!

In January 2022, we're going to start a Participatory Budgeting process in Pleasant View. Residents will have the chance to propose ideas for neighbourhood improvements and vote on how to spend \$500,000 in community funding. I can't wait to see the great ideas this neighbourhood will come up with!

City staff will be hosting a virtual community consultation session on Tuesday, December 7 from 6:00 - 8:00 PM. Development Updates

Don Valley North is one of the busiest and fastestgrowing areas in the city. That's why my team and I put together a central webpage where you can find information on all of the development projects in our ward. Many of you got involved in the RapidTO community meetings held this fall. RapidTO is exploring a number of ways to improve bus and streetcar transit across our city, which helps tackle congestion for us all. As there seems to have been some confusion around this policy, I want to make it clear that the City is **not** currently proposing dedicated bus lanes on any of our major roads here in Don Valley North. Rather, RapidTO is looking at a number of potential transit priority solutions based on what works best for each avenue. Learn more at toronto.ca/RapidTO.

Affordable Housing

I've had conversations with many of you about how expensive housing has become in our city. I don't know about you, but I want my grandkids to be able to live nearby. That's why I'm happy to share that Council is moving forward with our Inclusionary Zoning policy, which will create thousands more affordable units for hardworking Torontonians. This policy defines what is considered affordable and requires developers to set aside a certain percentage of units as affordable in new developments. While our neighbourhood was left out of the first stage of this policy, I have worked with the Mayor and City staff to make sure it's part of the policy review coming this summer.

Rooming House Update

It's clear that the status quo isn't working to solve the illegal rooming house issue that affects us here in the suburbs. I worked hard to improve the licensing framework that was proposed to Council in July based on your feedback. Mayor Tory supported this new framework, but felt that there needs to be better communication around this issue before we move forward. A report will come back to Council in the new year that formalizes many of the changes the Mayor and I made with City staff. For more information, visit shelleycarroll.ca/rooming-houses.
